**ORDER DIRECTING FILING BY COMPLAINANTS**

Effective Date: June 12, 2018

Complainants Lisa Lambert and Brett Felber have recently made filings with the Commission notifying the parties that they have filed for bankruptcy and indicating that they are no longer able to communicate with Spire. It is unclear from these filings whether the complainants wish to proceed with their complaint cases. Proceeding with the complaint cases will require the complainants to communicate with Spire to the extent necessary to

present their complaints to the Commission. As an alternative, if the complainants want no communication with Spire while their bankruptcy is pending, they may voluntarily dismiss their complaints without prejudice, meaning they could be re-filed at some point in the future. Since a procedural conference has been scheduled in GC-2018-0159 for next week, the Commission will direct the Complainants make a filing before that time, indicating whether they wish to continue their complaint cases.

**THE COMMISSION ORDERS THAT:**

1. No later than June 18, 2018, Lisa Lambert and Brett Felber shall file with the Commission a notice indicating whether they wish to continue their complaint cases or voluntarily dismiss those cases.
2. This order shall be effective when issued.
