## ORDER GRANTING MOTION FOR EXTENSION OF TIME

On November 22, 2022, Summit Natural Gas of Missouri, Inc. (SNGMO) filed a Third Motion for Variance. SNGMO did so due to operational and testing restrictions it endures due to COVID-19. The Commission ordered its Staff to file a Recommendation no later than December 28, 2022.

On December 19, 2022, Staff filed a Motion for Extension of Time. Staff states that to provide sufficient time to conduct further discovery, analyze data and information from SNGMO, and complete its investigation, Staff needs an additional 30 days in which to complete and file its recommendation.

The Commission finds Staff's motion reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time is granted.
2. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than January 27, 2023.
3. This order shall be effective when issued.
