ORDER DIRECTING RESPONSE TO SPIRE'S REQUEST FOR ORDER

This file was opened on August 10, 2018, when the Commission's Staff filed its Motion to Establish Docket to Enforce Spire Missouri Inc.'s Compliance with Commission Order Approving Unanimous Stipulation and Agreement. That motion explained that Spire is required to file a quarterly certificate of compliance as a condition of the Commission's approval of the merger of Laclede with MGE. In its last quarterly filing, Spire informed Staff that it intends to stop filing future certifications "unless the Commission, its Staff or other parties to this matter can provide a reasonable benefit for its continuance. Staff contends Spire cannot decide on its own to stop complying with a Commission order. Spire responded to Staff's motion on August 20 by requesting leave to cease filing the quarterly certificate of compliance.¹

Because Spire's request will affect the stipulation and agreement that resolved the 2013 merger case, the Commission will add the parties to that case as parties to this case. The Commission will also establish a deadline for the filing of responses to Spire's request.

THE COMMISSION ORDERS THAT:

1. All parties to File No. GM-2013-0254 are made parties to this case.
2. Any party wishing to respond to Spire Missouri, Inc.'s Request for Commission Order that Quarterly Certification Filings are No Longer Needed shall do so no later than September 21, 2018.
3. This order shall be effective when issued.




