### **THE COMMISSION ORDERS THAT:**

1. The Procedural Schedule adopted by the Commission in its Order of October 19, 2018, is amended, and Paragraphs 3(A) and 3(J)(viii) of the Procedural Schedule are deleted.
2. The Parties shall comply with the deadlines and procedures for discovery and, specifically, data requests, set out in the Commission's Rule 4 CSR 240-2.090.

3. This order shall be effective when issued.


