**STAFF RECOMMENDATION FOR APPROVAL OF
SPIRE'S COMPLIANCE TARIFF SHEETS**

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Recommendation For Approval of Spire's Compliance Tariff Sheets* (Recommendation) states as follows:

1. On May 13, 2020, Spire filed its tariff sheets in compliance with the Commission's May 13th *Order Approving Stipulation And Agreement* (Spire East Tariff Tracking No. YG-2020-0197 and Spire West Tariff Tracking No. YG-2020-0198) along with a *Motion for Expedited Treatment*. The tariff sheets bear an effective date of May 25, 2020.

2. On May 14th, Spire filed substitute tariff sheets to correct a calculation error.

3. On May 14th, the Commission issued its *Order Requiring Expedited Filing* directing Staff to file its recommendation on Spire's tariff filings no later than noon, May 15th.

4. Staff has reviewed Spire's tariff sheet filings for its Spire East and Spire West gas service territories. For reasons more fully explained in attached Staff Memorandum, Appendix "A" for Spire East and Staff Memorandum, Appendix "B"

for Spire West, incorporated herein for all purposes, Staff has determined that Spire's tariff filings (YG-2020-0197 for Spire East and YG-2020-0198 for Spire West) are in compliance with the Commission's May 13th *Order Approving Stipulation and Agreement* and recommends the Commission approve Spire's tariff sheet filings, as substituted May 14th, and as set forth in the Recommendation section of Staff Memorandum Appendix "A" for Spire East and Staff Memorandum Appendix "B" for Spire West.

WHEREFORE, Staff recommends the Commission approve Spire's tariff sheet filings as set forth in Staff's attached Memorandum Appendix "A" and attached Memorandum Appendix "B" to be effective May 25, 2020.
