**STAFF RECOMMENDATION TO APPROVE**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff Recommendation to Approve* respectfully states as follows:

1. On May 24, 2021, Spire Missouri Inc. d/b/a Spire filed a motion for expedited treatment and accompanying tariff revisions (Tariff Nos. YG-2021-0202 and YG-2021-0203) to extend its COVID-19 Residential Assistance Program (“Program”) an additional month.

2. The Program originated from the Amended Unanimous Stipulation and Agreement approved by the Commission in Case No. GU-2020-0376.

3. Staff has reviewed Spire’s motion and tariff sheet filings and recommends the Commission approve Spire’s tariff sheets. Staff further recommends the Commission grant Spire’s request for expedited treatment. The current Program will end on May 31, 2021, and in order to allow for continuity of the Program, Staff recommends the Commission permit the revised tariff sheets to become effective on June 1, 2021.

**WHEREFORE**, Staff recommends that the Commission approve Spire’s tariff sheets and grant Spire’s request to allow the revised tariff sheets (Tariff Nos. YG-2021-0202 and YG-2021-0203) to become effective on June 1, 2021; and grant such other and further relief as the Commission finds appropriate in the circumstances.


