### STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff Recommendation to Approve Tariff Sheets* respectfully states as follows:

- 1. On October 21, 2020, Spire Missouri Inc. d/b/a Spire filed a motion for expedited treatment of its COVID-19 Residential Assistance Program tariff along with tariff sheets P.S.C. MO. No. 7, Sheet No. R-31.4 for Spire East and P.S.C. MO. No. 8, Sheet No. R-31.4 for Spire West (Tariff Nos. YG-2021-0100 and JG-2021-0101) to comply with the Amended Unanimous Stipulation and Agreement approved by the Commission in File No. GU-2020-0376. The tariff sheets bear an effective date of November 20, 2020, but Spire has requested the Commission approve the tariff sheets by October 28, 2020, and further requested the Commission allow the tariff sheets to become effective on November 7, 2020.
- 2. Staff has reviewed Spire's motion and tariff sheets filings and recommends the Commission approve Spire's tariff sheets, and further recommends the Commission grant Spire's request to allow the tariff sheets to become effective on November 7, 2020.

WHEREFORE Staff respectfully recommends that the Commission issue an order approving Spire's filing of tariff sheets P.S.C. MO. No. 7, Sheet No R-31.4 for Spire East and P.S.C. MO. No. 8, Sheet No. R-31.4 for Spire West (Tariff Nos. YG-2021-0100 and JG-2021-0101) and grant Spire's request to allow the tariff sheets to become effective on November 7, 2020; and grant such other and further relief as the Commission finds appropriate in the circumstances.
