SPIRE MISSOURI INC'S NOTICE OF VERIFIED STATEMENT FOR PRE-QUALIFICATION FOR COMPETITIVE BIDDING OF ISRS-ELIGIBLE GAS UTILITY PLANT PROJECTS

COMES NOW Spire Missouri Inc ("Spire Missouri" or "Company") by and through counsel and files this Notice of Verified Statement for Pre-Qualification for Competitive Bidding of ISRS-Eligible Gas Utility Plant Projects and in support therefore states as follows:

- 1. On May 15, 2020, the Missouri House of Representatives passed House Bill 2120. This legislation included an addition to Section 393.1012.4, RSMo that requires gas corporations to develop and file with the Commission its pre-qualification process for contractors seeking to participate in competitive bidding to install ISRS-eligible gas utility plant and to file verification that the corporation has a process in place that conforms to the statutory requirements. The Missouri Public Service Commission ("Commission") has the authority to verify the statement to ensure compliance with this section. This legislation became effective August 28, 2020.
- On April 29, 2021, Spire Missouri filed a Notice of Pre-Qualification Process for
 Contractors Seeking to Participate in Competitive Bidding to Install ISRS-eligible Gas
 Utility Plant Projects, with the Commission which was assigned File No. GO-2021-0382.
- 3. On May 11, 2021, the Commission issued a *Notice Closing File* in this matter stating that the Commission did not need to take action on the plan the Company filed and closed the case.
- 4. This filing is closely related to the filing Spire Missouri made in this case on April 29, 2021.

 Pursuant to Section 393.1012.4, Spire Missouri has prepared the attached verified statement, attached as Exhibit A, confirming that Spire Missouri has in place a process for a pre-

- qualification for competitive bidding of ISRS-eligible gas utility plant projects and that this process confirms with the requirements of the ISRS statute.
- 5. This filing is being filed in advance of the statutory deadline of January 1, 2022, to ensure compliance with the new requirement and to allow time for the Commission to act in advance of any new ISRS filing made by the Company. *Id*
