ORDER SCHEDULING JOINT EVIDENTIARY HEARING AND SETTING PROCEDURAL SCHEDULE

Issue Date: April 12, 2016 Effective Date: April 12, 2016

On February 1, 2016, Laclede Gas Company ("Laclede") and Missouri Gas Company ("MGE"), an Operating Unit of Laclede Gas Company, filed verified applications and petitions to change their Infrastructure System Replacement Surcharge ("ISRS"). On April 11, the Office of the Public Counsel ("OPC") filed its *Motion for an Evidentiary Hearing* in both File Nos. GO-2016-0196 and GO-2016-0197. OPC opposes the inclusion in ISRS of infrastructure replacement costs that were not incurred by the time Laclede's and MGE's petitions were filed. Although the Commission previously issued a *Report and Order* on this issue in November 2015, ¹ OPC states that additional evidence will be presented at hearing.

The Commission will grant OPC's motion and schedule an evidentiary hearing. Since the pending actions in File Nos. GO-2016-0196 and GO-2016-0197 involve related

questions of law or fact, the Commission will order a joint hearing, as allowed by Commission rule 4 CSR 240-2.110(3).

THE COMMISSION ORDERS THAT:

- 1. The following procedural schedule is adopted:
 - a. Discovery issued after April 18, 2016, shall only pertain to matters contained in April 18 testimonies and that could not have been reasonably anticipated prior to April 18. Such discovery will be objected to in 1 business day and responded to in 2 business days.
 - b. Workpapers will be submitted within1 business day of filing testimony to which they related.
