**ORDER APPROVING TARIFF IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: May 10, 2017

Effective Date: June 1, 2017

The Commission issued an *Order Approving Unanimous Stipulation and Agreement* on April 26, 2017, authorizing Laclede Gas Company to submit tariff sheets to adjust its Infrastructure System Replacement Surcharge (ISRS) in both its Laclede and its Missouri Gas Energy (MGE) service territories. Laclede Gas Company filed tariff sheets (YG-2017-0220 and YG-2017-0219) purporting to comply with the Commission's order on April 27, 2017. The tariff sheets have a June 1, 2017 effective date.

The Commission issued an order setting a May 9, 2017 deadline for the filing of a recommendation by the Staff of the Missouri Public Service Commission (Staff) and any other party's response to the tariff sheets. Staff filed a recommendation, which stated that Staff had reviewed the tariff sheets and found them to be in compliance with the Commission's order and the unanimous stipulation and agreement of the parties. Staff recommended that the tariff sheets be approved. No other responses were received.

After reviewing the tariffs and the Staff recommendation, the Commission finds that Laclede's tariff sheets comply with the Commission's April 26, 2017 order and will approve them.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet, bearing Tariff No. YG-2017-0219, filed on April 27, 2017, by Laclede Gas Company for its Laclede service territory, is approved to become effective on June 1, 2017:
