**ORDER GRANTING JOINT MOTION TO RESCIND WAIVER**

Issue Date: December 20, 2017

Effective Date: December 30, 2017

On November 27, 2017, the City of Kennett, Missouri ("Kennett") and the Staff of the Commission ("Staff") filed a Joint Motion to Rescind Waiver ("Motion"). In the motion, Kennett and Staff explain that in File No. GE-2003-0503, the Commission granted Kennett's request to waive Commission Rule 4 CSR 240-40.030(15)(C). Kennett and Staff now wish the Commission to rescind that rule waiver.

That rule, if not waived, would have required Kennett to replace steel yard lines. The Commission waived the rule, and also instructed Kennett to conduct an annual instrument leak survey and an annual cathodic protection survey on the applicable yard line. Kennett has made the required annual filings with the Commission as ordered in File No. GE-2003-0503.

Kennett now states that the yard line is no longer in use, and that the property has not been used for several years. Thus, Staff and Kennett state that the waiver is no longer needed, and that the Commission should therefore rescind the waiver.

The Commission finds the Motion reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Joint Motion filed by the City of Kennett, Missouri and the Staff of the Commission is granted.
2. A copy of this order shall also be filed in File No. GE-2003-0503.
3. This order shall be effective on December 30, 2017.
4. This file shall be closed on December 31, 2017.
