**ORDER DIRECTING STAFF TO FILE PROPOSED RECONCILIATION**

On September 20, 2018, the Commission issued a *Report and Order* in this case, which will become effective on October 1, 2018. Section 386.420.4, RSMo 2016, requires the Commission to “cause to be prepared, with the assistance of the parties to such proceeding, and shall approve, after allowing the parties a reasonable opportunity to provide written input, a detailed reconciliation containing the dollar value and rate or charge impact of each contested issue decided by the commission, and the customer class billing determinants used by the commission to calculate the rates and charges approved by the commission in such proceeding.”

The Commission will order Staff to prepare and file a reconciliation and provide an opportunity for other parties to respond.

**THE COMMISSION ORDERS THAT:**

1. No later than October 9, 2018, the Commission’s Staff shall prepare and file the reconciliation required by Section 386.420.4, RSMo 2016.

2. Any party wishing to respond to the reconciliation prepared and filed by Staff shall do so no later than October 11, 2018.

3. This order shall be effective when issued.
