# STAFF RECOMMENDATION ON COMPLIANCE TARIFF FILING

COMES NOW the Staff of the Missouri Public Service Commission and pursuant to the Commission's September 24, 2018 Order Directing Staff to File a Recommendation and Setting Deadline for Responses submits its Staff Recommendation on Compliance Tariff Filing to the Commission as set forth in the attached memorandum, and in support states as follows:

- 1. On September 20, 2018, the Commission issued a *Report and Order* which authorized Spire Missouri Inc. ("Spire") to file tariff sheets for its Spire Missouri West service territory to establish an Infrastructure System Replacement Surcharge to recover the revenue as authorized in the *Report and Order* with an ISRS rate for each customer class as described in the *Report and Order*.
- 2. On September 21, 2018, Spire filed a tariff sheet intended to comply with the Commission's September 20<sup>th</sup> *Report and Order*, and on September 24, 2018, Spire filed a substitute tariff sheet, which tariff sheet bears a proposed effective date of October 21, 2018. This tariff filing has been designated as Tariff Tracking No. YG-2019-0048.
- 3. Also on September 21, 2018, Spire filed an *Application for Expedited*Treatment and Approval of Compliance Tariffs on Less Than 30 Days' Notice in which

Spire requested that the compliance tariff sheet become effective for service no later than October 5, 2018.

4. On September 24, 2018, the Commission issued an *Order Directing Staff* to *File a Recommendation and Setting Deadline for Responses* which ordered Staff to file, no later than September 27, 2018, a recommendation as to whether the compliance tariff sheet filed by Spire is in compliance with the Commission's *Report and Order* and whether Staff objects to the request for expedited treatment.

- 5. Staff's recommendation is attached hereto and is incorporated herein by reference. As reflected in the attached, Staff has reviewed the tariff sheet filed by Spire on September 21, 2018, as substituted on September 24, 2018, and has determined that the rates therein comply with those authorized by the Commission and that the substitute tariff sheet is in compliance with the Commission's *Report and Order*.
- 6. Given the circumstances under which this tariff was filed, Staff does not object to the request for expedited treatment.

WHEREFORE, Staff recommends that the Commission issue an order in this case that approves the following tariff sheet (Tariff Tracking No. YG-2019-0048) originally filed on September 21, 2018, as substituted on September 24, 2018, to go into effect on October 5, 2018, as requested by Spire:

On September 21, 2018, Spire Missouri Inc. ("Spire West" or "Company") filed "Spire Missouri Inc.'s Application for Expedited Treatment and Approval of Compliance Tariffs on Less than 30 Days' Notice". In addition, on September 21, 2018, Spire West provided a revised tariff sheet No. 12 in order to comply with the Commission's Report and Order – issued September 20, 2018 - in the above-referenced case. The effective date of the Company's September 21, 2018 tariff sheet was October 21, 2018.

On September 24, 2018, the Commission issued its "Order Directing Staff to File a Recommendation and Setting Deadline for Responses". The order directs Staff to file a recommendation not later than September 27, 2018.

On September 24, 2018, Spire filed a substitute tariff sheet, which tariff sheet bears a proposed effective date of October 21, 2018. This tariff filing has been designated as Tariff Tracking No. YG-2019-0048

The filed rates produce annual ISRS revenues of \$5,411,793<sup>1</sup>. This amount is consistent with what the Commission ordered in its Report and Order referenced above.
