ORDER SETTING PROCEDURAL CONFERENCE

On August 31, 2018, Spire Missouri, Inc. d/b/a Spire ("Company") filed a Request to Decrease WNAR. On September 20, 2018, the Commission suspended the tariff sheets from October 1, 2018, until April 1, 2019, and gave notice of a contested case.

The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference unless excused by the regulatory law judge. Parties wishing to appear by telephone will be provided with a telephone conference number.

THE COMMISSION ORDERS THAT:

1. A procedural conference will be held on October 2, 2018, beginning at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
