

Appellant expects to raise the following as issues: (1) that the Missouri Public Service Commission's October 30, 2019, Report and Order was unlawful, unjust, and/or unreasonable because it incorrectly allowed Spire to recover costs related to the replacement of cathodically protected steel mains for which there is no government mandated requirement to replace as required by the ISRS statute; (2) that the Missouri Public Service Commission's October 30, 2019, Report and Order was unlawful, unjust, and/or unreasonable because it incorrectly allowed Spire to recover costs related to the replacement of cathodically protected steel mains using an unlawful presumption of condition based on pipe material; and (3) that the Missouri Public Service Commission's October 30, 2019, Report and Order was unlawful, unjust, and/or unreasonable because it incorrectly allowed Spire to recover costs related to the replacement of cathodically protected steel mains for which there was insufficient evidence to prove said mains were worn out or in deteriorated condition, as required by the ISRS statute.
