On October 26, 2022, in the Commission's *Order Giving Notice of Case Filing, Directing an Answer, And Directing a Staff Investigation*, the Commission ordered the Staff of the Commission (Staff) to file a report no later than December 16. On December 8, in the Commission's *Order Denying Motion to Dismiss*, the Commission ordered Spire Missouri, Inc. d/b/a Spire (Spire) to file its Answer to the complaint no later than December 19, which means Spire's Answer is now due later than Staff's report. On December 14, Staff filed its request for extension, explaining that Spire's answer in this matter will impact its investigation and report, and requesting a 45-day extension to allow time for data request responses and analysis of facts in preparation of Staff's report.
