## RECORD OF PROCEEDINGS

JUDGE JONES: This is case number GC-2015-0111, Cloris and Ronald Torrey versus Laclede Gas Company. My name is Kennard Jones. I'm the regulatory law judge presiding over this case. At this time let's take entry of appearances, beginning with Laclede.

MR. ZUCKER: Rick Zucker,

Z-u-c-k-e-r, here for Laclede Gas Company, 700

Market Street, 6th Floor, St. Louis, Missouri
63101.

JUDGE JONES: And for the staff of the Commission?

MR. BORGMEYER: Yes. Appearing on behalf of the staff of the Missouri Public Service Commission, my name is John Borgmeyer.

And also we have Nichole Mers, and we have staff experts Bob Leonberger and Netelle Dietrich.

JUDGE JONES: And I'll note for the record that although the Office of Public Counsel is a party to all of the Commission cases, they have not entered an appearance in this case -- or I should say participated in this case. I will also note for the record that Mr. Ronald Torrey appeared with someone else,

who I don't know who he was. We were handed what is titled Affidavit, quote, "Rejection of Invitation to Contract for Discovery," end quote. Whatever this is hasn't been offered, just handed to us. I don't know if it's been filed in EFIS at this time or not. I'm just going to throw mine in the trash. I'm not even going to read it. If it's entered in EFIS then I'll have to take it into consideration.

Well, with that I'll issue an order accordingly. And does anyone have anything they'd like to add while on the record?

MR. ZUCKER: I would like to add

something, Your Honor.

JUDGE JONES: Yes.

MR. ZUCKER: We, Laclede filed a motion to dismiss this case, or a number of them, most recently in January, I believe. And there was an issue -- I think you gave the, Your Honor gave the Torrey's some time to respond. There was some confusion as to whether they met that time frame or not. It turned out that they did meet the time frame. And so the case was revived. But I would like to renew my motion to dismiss on the grounds that we have satisfied

the Torrey's request to stop trying to inspect the gas facilities in their home. And that is what they wanted in their request for relief in their complaint. And it's been satisfied. And so we would like everyone to acknowledge that the Torrey's will take yes for an answer, that in effect they won their case, and we would like to have the case dismissed. In the Torrey's response to our motion to dismiss they say that -- they have alleged a scheme to cover up some litigation, and that -- they have also alleged that we made the inspection, or tried to make the inspection in less than 36 months. And finally they allege that we tried to do some inspections in December.

My response would be, and I'll file something in the case if you like, that even if you take all three of those as, if you accept the truth of all three of those, they have in fact terminated service with Laclede Gas, so we are not trying to inspect the inside facilities, and so the case should be ended.

MR. BORGMEYER: So, Rick, they're no longer a customer at all?

MR. ZUCKER: They are not a customer.

1 They don't owe us anything. They have been 2 paying their bills on time and in full. So as 3 far as we're concerned until they want to 4 reactivate service, we don't need to get in to 5 do an inspection, and they are not customers at 6 this time. 7 MR. BORGMEYER: Okay, thanks. 8 JUDGE JONES: All right. Well then 9 let's --MR. ZUCKER: Would you like me to 10 11 file something to that effect? 12 JUDGE JONES: If you're going to file 13 what you just put on the record, we can just let the record be the motion. 14 15 MR.
