On January 15, 2018, Summit Natural Gas of Missouri, Inc. ("SNGMO") filed the above-referenced application. The Commission ordered its Staff to file a Recommendation.

On February 15, 2018, Staff filed a Report in which it asked the Commission to order Staff to file a Recommendation or alternative pleading no later than April 15, 2018.

Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered. The Commission issued no order to the contrary of that rule, ten days have elapsed since Staff's request, and no party has responded. Thus, the Commission will take up Staff's request unopposed.

The Commission finds Staff's request reasonable, and will grant it.
