On May 19, 2023,<sup>1</sup> Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation no later than July 6. Staff timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until October 13. No party filed a response to the extension request.<sup>2</sup> The Commission finds the unopposed request reasonable and will grant the extension of time request.

1. Staff shall submit its recommendation or an appropriate alternate filing no later than October 13, 2023.
