**ORDER GRANTING STAFF'S THIRD MOTION FOR AN
EXTENSION OF TIME TO FILE A RECOMMENDATION AND
SETTING A TIME FOR RESPONSES**

The Commission directed its Staff (Staff) to file a recommendation about Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (Liberty Midstates) application to issue long-term unsecured debt. Staff's recommendation was originally due March 29, 2023. The Commission granted two Staff requests for extensions of time to file a recommendation. Staff's recommendation is currently due on May 26, 2023.

On May 24, 2023, Staff filed a third request for an extension of time to file its recommendation. In support of its position, Staff states that Liberty Midstates filed an Amended Financing Application on May 19. Staff requests an additional 30 days to complete its recommendation on the amended application. The Commission will grant the extension

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation in this matter no later than June 26, 2023.

2. Any responses to Staff's recommendation or Liberty Midstates' application shall be filed no later than July 7, 2023.
