LOCAL PUBLIC HEARINGS**

On November 13, 2013, the Commission issued an order adopting a procedural schedule recommended by the parties. The schedule allows for local public hearings to be held from February 17 to February 28, 2014. On November 15, the Office of the Public Counsel filed suggestions for the local public hearings. With the exception to the location of the Joplin hearing, the Commission will set the hearings according to Public Counsel's suggestions. The hearings will continue until the end time indicated or until no one present wishes to make a statement.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Information Office shall make an informational presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing.
2. Missouri Gas Energy, the Staff of the Commission, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session. Any other party may also do so.
3. No later than 10 days before the local public hearings, Missouri Gas Energy shall provide individual notice of the hearings to each of its customers.
