ORDER SETTING LOCAL PUBLIC HEARINGS

Issue Date: March 12, 2014

Effective Date: March 12, 2014

The Missouri Public Service Commission is setting local public hearings as recommended ("recommendations") and granting the motion to file out of time ("motion") filed in its *Local Public Hearing Recommendations and Motion for Leave to File Out of Time*.¹ Staff states that an extra day was necessary to present the confirmed and unopposed settings in the recommendations. Those facts constitute good cause, so the Commission will grant the motion and set the local public hearings in accordance with the recommendations.

THE COMMISSION ORDERS THAT:

1. The motion for leave to file out of time is granted.
2. Schedule. The Commission will convene public meetings as set forth in the appendix. Each meeting will begin with a question-and-answer session at which the Commission's staff ("Staff") will discuss the rate increases at issue in this action. Following the question-and-answer session, a regulatory law judge shall conduct a local public hearing to take public comment.

3. Statements. At each question-and-answer session Summit Natural Gas of Missouri, Inc. ("Summit"), Staff, and the Office of the Public Counsel shall each set forth its perspective on the action by making available:

- a. A written statement, not more than one page, with sufficient copies for the attendees; and
- b. At least one representative in person to address substantive issues and respond to questions from the attendees.

4. Notice.

- a. Summit shall provide an individual notice to each of its customers no later than ten days before the earliest local public hearing.
- b. The Commission's Data Center shall serve a copy of this order on the governing body of each county in Summit's service areas.
- c. The Public Information Office of the Missouri Public Service Commission shall make notice of this order available to members of the General Assembly representing the residents of the applicants' service areas.

5. This order shall become effective upon issuance.
