**STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its recommendation to approve SNG's compliance tariffs hereby states:

1. On October 29, 2014, the Commission issued its *Report and Order* authorizing Summit Natural Gas of Missouri (SNG) to file tariff sheets designed to collect an additional \$7.1 million from its natural gas customers in Missouri.

2. On November 14, SNG filed tariff sheets to comply with the order, along with a motion for expedited treatment requesting the Commission allow the tariff sheets to go into effect on December 1, 2014. The Commission ordered Staff to file its recommendation regarding those compliance tariff sheets no later than noon on November 21.

3. On November 19, SNG filed one substitute tariff sheet in response to Staff comments.

4. As explained in Staff's *Memorandum*, attached here as Appendix A and incorporated by reference, SNG's filing consolidates its two tariff books into a new P.S.C. MO No. 3 tariff book. Staff reviewed SNG's compliance tariff sheets filed on November 14 and November 19, and found that they comply with the Commission's *Report and Order*. Staff recommends the Commission grant SNG's motion for

expedited treatment, because the requested effective date of December 1, 2014, is consistent with the Commission's January 8, 2014, *Notice of Contested Case and Order Suspending Tariff and Delegating Authority*, which suspended SNG's filed tariff sheets until December 1, 2014.

**WHEREFORE**, Staff recommends the Commission approve following tariff sheets, as filed in this case on November 14, 2014 and as substituted on November 19, 2014, with an effective date of December 1, 2014:

DATE: November 21, 2014

On October 29, 2014, the Missouri Public Service Commission (Commission) issued its Report and Order in Case No. GR-2014-0086, the Summit Natural Gas of Missouri, Inc. (SNG or Company) natural gas rate case. This order approved an increase in SNG's overall Missouri jurisdictional gross annual natural gas revenues of approximately \$7.1 million.

On November 14, 2014, the Company filed tariff sheets to comply with the order. On November 19, 2014, SNG a filed Substitute Tariff Sheet. The Substitute Tariff Sheet filing included minor changes suggested by the Energy Unit – Tariff, Safety, Economic and Engineering Analysis Department (Staff). In its letter of transmittal accompanying the November 14, 2014 compliance filing, SNG requested expedited treatment to reflect an effective date of December 1, 2014, which is less than the standard 30-day period, but which complies with the Commission's suspension of SNG's original tariff filing in this case. With this filing, SNG will consolidate its P.S.C. MO No. 1 and P.S.C. MO No. 2 books into a new P.S.C. MO No. 3 tariff book.

On November 14, 2014, the Commission issued an *Order Setting Time For Filing Responses*. On November 17, 2014, the Commission issued an, *Order Directing Filing of Recommendation*.

The Staff has reviewed the tariff sheets filed by SNG on November 14, 2014, and as substituted on November 19, 2014, is of the opinion that these sheets are in compliance with the Commission's *Report and Order* in this case.

Staff has verified that SNG has filed its annual report and is not delinquent on any assessment. Therefore, Staff recommends the following tariff sheets, filed on November 14, 2014, and as substituted on November 19, 2014, with an effective date of December 1, 2014, be approved:


