Re: Misrepresentation of Identity in Obtaining Utility Service

Dear Ms. Lambert and Mr. Felber,

As you are aware, gas service at 2865 Dividend Park (the 'Residence') was disconnected for non-payment on April 18, 2017. You have made no payment since that date to cure your default. However, you have attempted to have gas service restored by various other means, including applying for commercial service at the Residence under the business name Doggie Designs.

It has now come to our attention that you obtained commercial service at the Residence on December 27, 2017, by Mr. Felber misrepresenting himself as applying for service on behalf of a church named the Church of Jesus & Hope. We erred in not denying your application and, as a result, you have enjoyed gas service for the past two weeks without having made any payment on the balance owed under the residential account at the Residence.

This letter shall serve as a notice of disconnection due to your violation of Missouri Public Service Commission Rule 13.050(1)(G), and Spire Missouri Tariff Rule 14(1)(F), for misrepresentation of identity in obtaining utility service.

Your natural gas service will be disconnected on or after January 26, 2018. After services are disconnected, if you would like to discuss restoration of services under the Cold Weather Rule, please call us at 314-621-6960.
