## ORDER SETTING DEADLINE FOR FILING RESPONSE TO STAFF RECOMMENDATION

Issue Date: December 15, 2016 Effective Date: December 15, 2016

The Commission's Staff filed a recommendation on Summit Natural Gas of Missouri, Inc.'s ("Summit") 2014-2015 Actual Cost Adjustment (ACA") filing. Staff evaluated Summit's gas purchasing practices for the relevant ACA period in order to evaluate the prudency of the company's actions. Staff also conducted a reliability analysis, hedging review, and comparison of Summit's billed revenues and its actual gas costs to determine if there was an over-recovery or under-recovery of the ACA balances. Staff recommended dollar adjustments be made to the ACA balances and identified concerns and recommendations.

The Commission will direct Summit to submit a response to Staff's recommendation.

#### THE COMMISSION ORDERS THAT:

- Summit Natural Gas Company of Missouri, Inc., shall file a response to Staff's recommendation no later than January 30, 2017.
- 2. Any other entity wishing to comment on Staff's recommendation shall do so no later than January 30, 2017.
