On December 1, 2017, the Staff of the Commission filed its Actual Cost Adjustment ("ACA") Recommendation for the 2015-2016 ACA of Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty Utilities"). Staff recommends certain adjustments to Liberty Utilities' ACA account balances. Staff further recommends that Liberty Utilities change its practices for Billed Revenue and Actual Gas Costs, Reliability Analysis and Gas Supply Planning, and Hedging. Staff asks Liberty Utilities to respond within 45 days.

The Commission will order Liberty Utilities to respond.

THE COMMISSION ORDERS THAT:

1. Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities shall respond to the Staff Recommendation no later than January 16, 2018.

2. This order shall be effective when issued.
