In reviewing the transcripts the Commission has found the scrivener's errors as set out in the Ordered Paragraphs below. Therefore, the Commission corrects those transcripts with this order.

Additionally, when originally filed on January 23, 2018, the Affidavit of Timothy W. Krick,¹ was marked "confidential" at the request of Spire Missouri, Inc. At the hearing on February 5, 2018, counsel for Spire Missouri stated that the entirety of the document could be made public and that document was later also entered into the record as a public document. Since that document is now public, the Commission will change the "confidential" designation to "public" on the original filing. Therefore, by this order, the Commission will direct its Data Center to remove the "confidential" designation in the Electronic Filing and Information System (EFIS) and make this a public document.
