**MOTION TO SUSPEND TIME FOR FILING PROPOSED PROCEDURAL SCHEDULE  
AND MOTION TO DISMISS**

COMES NOW Kansas City Power & Light Company ("KCPL") for its proposed procedural schedule states to the Missouri Public Service Commission ("Commission") as follows:


1. On October 21, 2004, the Commission issued an Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule in this docket. In that order, the Commission set a prehearing conference on November 1, 2004 and directed the filing of a proposed procedural schedule by the parties no later than November 8, 2004.
2. On November 1, 2004, KCPL and representatives from both the Commission and the Office of the Public Counsel participated in the prehearing conference. The Complainant did not appear at this prehearing conference.
3. KCPL requests the Commission issue an order dismissing the Complainant's complaint for failure to appear at the prehearing conference pursuant to Commission Rule 4 CSR 240-2.090(5) or 4 CSR 240-2.116(3).
4. While the motion to dismiss is pending, KCPL requests the Commission suspend the requirement to file a proposed procedural schedule by November 8, 2004.

WHEREFORE, KCPL prays that the Commission:

1. issue an order dismissing the Complainant's complaint for failure to appear at the prehearing conference and
2. suspend the requirement to file a Proposed Procedural Schedule until the Commission rules on the motion to dismiss.


