**SPRINT'S MOTION TO CHALLENGE  
HIGHLY CONFIDENTIAL DESIGNATIONS**

COMES NOW Sprint Missouri, Inc. and Sprint Communications, L.P.

(collectively "Sprint"), and hereby files its Motion to Challenge the Highly Confidential designations of Southwestern Bell Telephone Company d/b/a/ SBC Missouri ("SBC") and CenturyTel of Missouri, LLC and Spectra Group LLC d/b/a Century Tel ("CenturyTel").

1. On November 5, 2003 the Commission issued an Order creating this case and establishing filing deadlines for certain information. In that Order, the Commission stated that any party or proposed intervenor that plans to challenge the FCC's finding of impairment for mass market switching, loops and transport must file a pleading stating that intent no later than November 12, 2003. That Order further required the pleading to include specific, detailed information supporting the party's case.

2. In response to the Commission's directive, SBC Missouri and CenturyTel made filings addressing their plans regarding the FCC's national impairment findings in Missouri. SBC Missouri and CenturyTel also filed responses indicating that it was their intent to challenge the FCC's findings for mass market local switching, enterprise loops and dedicated transport for geographic market(s) in Missouri.

3. In stating their intent to challenge the FCC's presumptions, both SBC Missouri and CenturyTel marked as Highly Confidential the companies that had switches in the SBC and CenturyTel proposed market areas, the Metropolitan Service Area ("MSAs"), as well as the companies that had facilities subject to the transport routes identified by them. While SBC and CenturyTel have failed to state the reasons they marked the information as Highly Confidential, neither of these types of information should be classified as Highly Confidential.

Switch Providers:

4. The name of switch providers in any given geographical area in the United States is publicly available information. This information is publicly *available* through the Local Exchange Routing Guide ("LERG"). This was also publicly filed with the Federal Communications Commission in the case that resulted in the Triennial Review Order. The record of the FCC case contains the name of the switch provider, the type of switch, the city in which switch is located *and the street address*. See UNE Fact Report 2002, April 2002, CC Docket No 01-338 at Appendix B (Missouri specific page at Attachment A). Further, other ILECs, SBC affiliates included, have publicly filed this information. (See Sprint Motion to Modify the Protective Order at Attachment A). Therefore, Sprint requests this information be reclassified as non-proprietary.

Transport Facilities Providers:

5. In SBC and CenturyTel's filings, they publicly list all routes upon which they will challenge the federal presumption. However, SBC and CenturyTel mark the list of potential facilities providers on those routes as Highly Confidential. Sprint does not agree that a list of facilities providers, not associated with any given route, merits a

Highly Confidential designation. Further, some of these facilities providers commercially offer their services. Therefore, for these specific providers, there would be no basis to attach any confidential designation to their names.

6. Based on the above, Sprint requests that the Highly Confidential designations contained in SBC's November 10<sup>th</sup> filing and CenryTel's November 12<sup>th</sup> filing be reclassified. Further, Sprint requests that for all future filings, the party designating the information as Highly Confidential in any pleading be required to make a demonstration that such a designation is justified.
