ORDER APPROVING RECONCILIATION OF CONTESTED ISSUES

On June 27, 2016, the Commission issued an order directing the Commission’s Staff to file reconciliations containing the dollar value and rate or charge impact for the January and February 2016 projects approved for inclusion in the Infrastructure System Replacement Surcharge in File No. GO-2016-0196 and File No. GO-2016-0197. The Commission also set a June 28 deadline for parties to submit their written input on Staff’s reconciliations. Staff timely filed reconciliations for both cases. No party responded to or objected to Staff’s filings.

The Commission finds the reconciliations submitted by Staff are accurate representations of the revenue requirement impact of the contested issues decided by the Commission in its May 19 Report and Order. The Commission further finds that the submitted reconciliations satisfy the requirements of Section 386.420.4, RSMo (Cum.Supp. 2013).

THE COMMISSION ORDERS THAT:

1. The reconciliation filed by the Commission's Staff in File No. GO-2016-0196 is approved.
2. The reconciliation filed by the Commission's Staff in File No. GO-2016-0197 is approved.
3. This order shall be effective when issued.
