DIRECTING STAFF TO FILE RECONCILIATION, AND SETTING
DEADLINE FOR SUBMITTING WRITTEN STATEMENTS**

The Commission will grant Public Counsel's *Motion for Expedited Treatment* and direct the Commission's Staff to file a reconciliation that contains the dollar value and rate or charge impact for the January and February 2016 projects approved by the Commission for inclusion in the Infrastructure System Replacement Surcharge. Staff's reconciliation will include customer class billing determinants that are calculated in compliance with Section 393.1015.5, RSMo (Cum.Supp. 2013).

The Commission will also set a deadline for other parties to submit written statements on Staff's reconciliation.

THE COMMISSION ORDERS THAT:

1. Public Counsel's *Motion for Expedited Treatment* is granted.
2. Staff shall file a reconciliation as described in the body of this order no later than June 28, 2016.

3. No later than June 29, 2016, Parties may submit written statements on the reconciliation identified in ordered paragraph 2.

4. This order shall be effective when issued.
