- **SUBJECT:** Staff Report and Recommendation Regarding Spire East's ISRS Tariff Submission - Compliance Filing
- **DATE:** November 16, 2020

On November 12, 2020, the Commission issued its "Order Approving Stipulation and Agreement" ordering Spire Missouri Inc., d/b/a Spire ("Spire East") to file compliance tariff sheets by November 13, 2020 and for Staff to file a recommendation regarding Spire's compliance tariff sheets by November 16, 2020 at 4:00 p.m.

On November 12, 2020, Spire East filed "Spire Missouri, Inc.'s Motion for Expedited Treatment," a cover letter, and Sixth Revised Sheet No. 12 – a compliance tariff sheet (YG-2021-01117). The proposed effective date on the tariff sheet is December 12, 2020. However, in its motion, Spire East requests an effective date of November 22, 2020.

Staff reviewed Spire East's tariff sheet and finds that it complies with the Commission's November 12, 2020 order. Staff does not object to expedited treatment which provides for at least 10 days between the issue date and the effective date of the Commission order approving the tariff sheet. This is consistent with the September 28, 2018 Commission "Order Granting Expedited Treatment and Approving Tariff Filings in Compliance with Commission Order" in Case Nos. GO-2018-0309 and GO-2018-0310.

Spire filed its 2019 annual report with the Commission.

As of the issuance of this memo, Spire East is not delinquent on its FY 2020 assessments.

RECOMMENDATION

Based upon the rationale stated above, Staff recommends the Commission issue an order in this case that:

 Approves Spire East's ISRS tariff sheet (YG-2020-0117) P.S.C. MO No. 7 Sixth Revised Sheet No. 12 filed on November 12, 2020. 2. Approves an effective date for the tariff sheet which is at least 10 days after the Commission's order.
