On March 22, 2017, Veolia Energy Kansas City, Inc. (Veolia) filed a Motion for Expedited Treatment for Revised 2017 PACC Filing. Veolia stated that it found an error in its previous filings and requested that the Commission consider changes to its tariff on an expedited basis after the Staff of the Missouri Public Service Commission (Staff) has an opportunity to review the amended filings. The Commission will direct Staff and any other party to respond as set out below.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file either a recommendation regarding the amended tariff filing or a response stating when it expects to be able to make such a filing, no later than March 27, 2017.
2. Any other party wishing to respond to the March 22, 2017 filings shall do so no later than March 27, 2017.
3. Any replies to the March 27, 2017 filings shall be made no later than March 28, 2017.

4. This order shall be effective when issued.
