STAFF RECOMMENDATION TO APPROVE TARIFF

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its Recommendation in response to the Commission's Order Directing Filing states as follows:

- 1. On February 1, 2017, Veolia Energy Kansas City, Inc. ("Veolia") filed tariff sheets (Tracking No. YH-2017-0154) to revise its Production Adjustment Cost Clause ("PACC") rates for steam service. The revised tariff sheets have a proposed effective date of April 1, 2017.
- 2. On March 3, 2017, Staff filed its recommendation and determined that the revised tariff sheets were in compliance with Veolia's Tariff Sheet Nos. 36 and 37 and the Commission's Report and Order which approved the PACC in Case No. HR-2014-0066.
- 3. On March 22, 2017, Veolia filed substitute revised tariff sheets and notified the Commission that it had inadvertently omitted 150 Mlbs of steam revenue from its February 1, 2017 filing.
- 4. As set forth in the attached Memorandum, Staff has reviewed Veolia's substitute revised tariff sheets filed on March 22, 2017, and has determined that they are in compliance with Veolia's Tariff Sheet Nos. 36 and 37 and the Commission's Report and Order which approved the PACC in Case No. HR-2014-0066.

WHEREFORE, for the reasons stated above, Staff recommends the Commission approve Veolia's two substitute revised tariff sheets filed on March 22, 2017, under tracking number YH-2017-0154 and bearing effective dates of April 1, 2017.

On February 1, 2017, Veolia Energy Kansas City, Inc. ("Veolia") filed with the Commission two (2) tariff sheets for steam service to implement the Production Adjustment Cost Clause ("PACC") for the twelve (12) months starting April 1, 2017 through March 31, 2018. The adjustment is required by Veolia's PACC, which the Commission approved in Case No. HR-2014-0066, effective August 1, 2014.

On February 2, 2017, the Commission directed Staff to file a recommendation on the pending tariff no later than March 3, 2017. On March 3, Staff issued its recommendation to approve Veolia's PACC tariffs. On March 22, Veolia filed a revised tariff to account for an error Veolia discovered subsequent to submitting its PACC filing. Veolia inadvertently omitted 150 Mlbs of steam revenue from Veolia's PACC calculation. Also on March 22, Veolia filed a substitute to the revised tariff.

Staff has reviewed the substitute tariff filed on March 22 and concluded that the revised rate of negative (\$0.44636) per Mlb is the correct rate resulting from the additional 150 Mlbs of steam sales. The revised rate is a change from negative (\$0.44575).

Staff Recommendation

Staff has reviewed the filed substitute tariff sheets and recommends approval of the following tariff sheets to go into effect for service on and after April 1, 2017, the requested effective date:

P.S.C. MO. No. 1 2nd Revised Sheet No. 36 Cancelling 1st Revised Sheet No. 36

2nd Revised Sheet No. 37 Cancelling 1st Revised Sheet No. 37

Staff has verified that Veolia is not delinquent on any assessment and has filed its Annual Report. Veolia is current on its submission of its Surveillance Monitoring reports as required in 4 CSR 240-20.090(10) and its monthly reports as required by 4 CSR 240-3.161(5). Staff is not aware of any other matter pending before the Commission that affects or is affected by this tariff filing. Staff's recommendation for approval of the PACC change in this case is solely based on the accuracy of Veolia's calculations.
