**ORDER OF CORRECTION CORRECTING THE NAME OF APPLICANT**  
**SENDERO SMGC LIMITED ACQUISITION COMPANY, LLC**

On April 26, 2005, the Commission approved a non-unanimous stipulation and agreement. Among other things, the Commission's order allowed DTE Enterprises, Inc., and DTE Ozark, Inc., to sell their limited partnership interests in Southern Missouri Gas Company, L.P., to "Sendero SMGC LP Acquisition Company, LLC."

On May 24, DTE Enterprises, DTE Ozark, Sendero SMGC GP Acquisition Company and Sendero SMGC Limited Acquisition Company, LLC, filed a Motion for a Notice of Correction Correcting the Name of Applicant Sendero SMGC Limited Acquisition Company, LLC and Motion for Expedited Treatment. In that motion, the applicants explained that their First Amended Application incorrectly referred to the company as "Sendero SMGC LP Acquisition Company, LLC," instead of its correct name of Sendero

SMGC Limited Acquisition Company, LLC. Because of that error, the Commission's order refers to the applicant incorrectly.

The movants ask the Commission to issue a Notice of Correction. The movants also filed a Motion for Expedited Treatment in which they ask the Commission to issue the Notice of Correction no later than May 26, 2005. The movants ask for expedited treatment because of their plans to close the transaction on May 26. Finally, the movants state that the Staff of the Commission and the Office of the Public Counsel do not object to the motion.

The Commission has reviewed the motion, finds it reasonable, and will grant it.

**IT IS THEREFORE ORDERED:**

1. That the Motion for a Notice of Correction Correcting the Name of Applicant Sendero SMGC Limited Acquisition Company, LLC, and Motion for Expedited Treatment is granted.
2. That the Commission's April 26, 2005 Order Approving Non-Unanimous Stipulation and Agreement and Approving Application is corrected to delete all references to "Sendero SMGC LP Acquisition Company, LLC," and to substitute the correct name of the applicant, which is Sendero SMGC Limited Acquisition Company, LLC.
3. That DTE Enterprises, Inc., may sell its limited partnership interest in Southern Missouri Gas Company, L.P., to Sendero SMGC Limited Acquisition Company, LLC.
4. That DTE Ozark, Inc., may sell its limited partnership interest in Southern Missouri Gas Company, L.P., to Sendero SMGC Limited Acquisition Company, LLC.

5. That this order shall become effective on May 26, 2005.
