## ORDER ESTABLISHING ENDING ACA BALANCES

Effective Date: January 25, 2014

The Commission opened these cases to receive the 2006-2007, 2007-2008, 2008-

2009, 2009-2010, and 2010-2011 Actual Cost Adjustment (ACA) filings of Union Electric

Company d/b/a Ameren Missouri. Each of the cases has been held open for several years

pending resolution of the MoGas Pipeline, LLC transportation overcharge issue. That issue

was resolved in 2013 when Ameren Missouri entered into an agreement with MoGas Pipeline by which it obtained refunds from MoGas. Ameren Missouri has now returned those refunds to its customers through its PGA mechanism.

On December 31, 2013, the Staff of the Public Service Commission filed a recommendation and memorandum indicating that the MoGas Pipeline transportation overcharge issue has been resolved and that there are no other issues remaining. Staff set out the ending ACA balances for each year and advised the Commission to issue an order establishing those ending ACA balances. More than ten days have passed since Staff filed its recommendation and no party has responded to that recommendation.

After reviewing Staff's recommendations, the Commission concludes that Staff's recommendations should be accepted as a resolution of Ameren Missouri's 2006-2007, 2007-2008, 2008-2009, 2009-2010, and 2010-2011 ACA audits. Because Staff's recommendations are unopposed, the Commission will give this order a ten-day effective date.
