ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION
REPORT AND ORDER

Issue Date: March 2, 2006

Effective Date: March 6, 2006

In an Order Approving Stipulation and Agreement issued on February 28, 2006, the Commission rejected a tariff filed by Aquila, Inc. The Commission, however, authorized Aquila to file a revised tariff that was agreed to as part of the approved stipulation and agreement. Aquila filed a revised tariff on February 28.

The tariff sheets filed by Aquila on February 28 carry an effective date of March 30. However, Aquila filed a Motion along with its tariff, requesting that the Commission expedite its consideration of the tariff so that the tariff can go into effect on March 6, as provided in the Commission's order approving the stipulation and agreement.

Staff filed its recommendation regarding Aquila's tariff on March 1. Staff indicates that the tariff complies with the approved stipulation and agreement, and recommends that the Commission approve the tariff to become effective on March 6. No other party has filed a recommendation regarding the tariff.

Based on Staff's recommendation, the Commission determines that the tariff complies with the approved stipulation and agreement. The tariff will be approved effective for service on and after March 6, for good cause shown, in compliance with Section 392.140(11), RSMo 2000.

IT IS ORDERED THAT:

1. The following tariff filed February 28, 2006, and assigned Tariff No. YH-2006-0650, is approved to become effective on March 6, 2006:
