On January 15, 2009, KCP&L Greater Missouri Operations Company ("GMO"), submitted a proposed tariff sheet that contains a guarterly cost adjustment to allow customer rates to change with fuel cost changes. The tariff sheet was filed pursuant to the terms of the Stipulation and Agreement approved by the Commission in Case No. HR-2005-0450. GMO's tariff sheet, Tariff No. YH-2009-0515, has a proposed effective date of March 1, 2009.

On February 11, 2009, the Commission's Staff filed a recommendation stating that it has reviewed Tariff No. YH-2009-0515 and is of the opinion that it has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff sheet and complies with the Commission's order in Case No. HR-2005-0450. Staff recommends that the Commission approve the proposed tariff sheet to become effective on March 1, 2009. No objections to the tariff were filed and no entity filed a response to Staff's recommendation.
