ORDER DIRECTING NOTICE, ADDING PARTIES,
AND DIRECTING FILING

On April 16, 2007, Aquila, Inc., d/b/a Aquila Networks-L&P, filed a steam service tariff sheet providing the current Quarterly Cost Adjustment for service provided to steam customers in the company's L&P service territory. The tariff sheet bears an effective date of June 1, 2007.

The Commission finds that notice of the tariff filing shall be given to the parties to Aquila Networks-L&P's most recent steam rate case. In addition, the Commission shall make AG Processing, Inc., a party to this case without the need for intervention, since it has previously participated in Aquila's last steam Quarterly Cost Adjustment case. The Commission will also set dates for the filing of the Staff's recommendation and for any responses to Staff's recommendation.

IT IS ORDERED THAT:

1. The Commission's Data Center shall serve a copy of this order on all parties to Case No. HR-2005-0450, the most recent steam rate case of Aquila, Inc., d/b/a Aquila Networks-L&P.

2. AG Processing, Inc., is made a party to this case without the need for formal intervention.
