### ORDER APPROVING COMPLIANCE TARIFF SHEETS

The Missouri Public Service Commission is approving the tariff sheets ("compliance tariff sheets") filed in compliance with the Commission's order dated October 12, 2011.

On October 13, 2011, Veolia Energy Kansas City, Inc. filed the compliance tariff sheets. On October 27, 2011, Staff filed *Staff's Recommendation on Compliance Tariffs* ("recommendation"). Staff recommends approval of the compliance tariff sheets as conforming to the Commission's order dated October 12, 2011. No hearing is necessary before approving the compliance tariff sheets,<sup>1</sup> so this action is not a contested case and the Commission need not separately state its findings of fact.

Based on the affidavits filed, the Commission independently finds and concludes that the compliance tariff sheets support safe and adequate service as just and reasonable rates, and will approve the compliance tariff sheets.

- 1. The tariff assigned Tracking Nos. YH-2012-0162 and YH-2012-0163 are approved.
