On October 23, 2018, the Staff of the Commission filed its *Notice of Extension* informing the Commission that in accord with Commission Rule 4 CSR 240-3.050(12), and by mutual agreement with the Veolia Energy Kansas City, Inc. and the Office of the Public Counsel, the timeline to file the 150 day disposition agreement was being extended by an additional 14 days from the previous extension to October 23, 2018.
