- JUDGE WOODRUFF: Well, welcome everyone.
- 3 This is Case No. ER-2005-0436 and HR-2005-0450. This was
- 4 scheduled to begin hearing today, and I believe the
- 5 parties have something -- well, let's go ahead and do
- 6 entries of appearance first, beginning with Aquila.
- 7 MR. SWEARENGEN: Yes. James C. Swearengen
- 8 and Janet Wheeler, Brydon, Swearengen & England, appearing
- 9 on behalf of Aquila. Thank you.
- JUDGE WOODRUFF: And for Staff?
- 11 MR. WILLIAMS: Nathan Williams, P.O.
- 12 Box 360, Jefferson City, Missouri 65102.
- 13 JUDGE WOODRUFF: For Public Counsel?
- 14 MR. MILLS: Lewis Mills on behalf of the
- 15 Office of the Public Counsel and the public. My address
- is Post Office Box 2230, Jefferson City, Missouri 65102.
- JUDGE WOODRUFF: For AARP?
- 18 MR. COFFMAN: Thank you. John B. Coffman
- 19 representing AARP. My address is 871 Tuxedo Boulevard,
- 20 St. Louis, Missouri 63119.
- 21 JUDGE WOODRUFF: Thank you. Ag Processing
- 22 and Sedalia Industrial Energy Users are represented by Stu
- 23 Conrad, and Mr. Conrad sent me an e-mail a few minutes ago
- 24 and I excused him from being here today.
- Is anyone here for Calpine?

- 1 (No response.)
- JUDGE WOODRUFF: City of Kansas City?
- 3 MR. COMLEY: Let the record reflect the
- 4 entry of appearance of Mark W. Comley, Newman, Comley &
- 5 Ruth, Post Office Box 537, Jefferson City, Missouri 65102,
- 6 on behalf of the City of Kansas City.
- 7 JUDGE WOODRUFF: And City of St. Joseph?
- 8 MR. STEINMEIER: William D. Steinmeier,
- 9 William D. Steinmeier, PC, on behalf of the City of
- 10 St. Joseph, Missouri.
- JUDGE WOODRUFF: And for The Empire
- 12 District, I don't see Mr. Keevil.
- 13 Federal Executive Agencies?
- 14 MR. WILLIAMS: Judge, this is Nathan
- 15 Williams. I spoke with Major Paulson this morning, and he
- 16 indicated he's down in Florida and wasn't appearing here
- in anticipation of this case settling, and he didn't make
- 18 the trip up for that reason.
- JUDGE WOODRUFF: Very good. Department of
- 20 Natural Resources? I don't believe Ms. Woods is here yet.
- 21 I believe that's all the parties.
- Now I'll ask Aquila, I understand that
- 23 there was a settlement reached in this case?
- MR. SWEARENGEN: Yes, your Honor. We've
- 25 reached an agreement and reduced it to writing and hope to

- 1 have it filed later this afternoon. However, it will not
- 2 be a Unanimous Stipulation & Agreement. There are several
- 3 parties who have indicated that they're not willing to
- 4 sign the document, and I would let them speak as to
- 5 whether or not they've formed an intention as to whether
- 6 or not they will ultimately oppose it and request a
- 7 hearing.
- 8 But those parties that we have been able to
- 9 reach agreement with have indicated they will sign. Some
- 10 of them have already signed the document. So we hope to
- 11 have something filed shortly in the electric case.
- 12 JUDGE WOODRUFF: Which are the parties that
- 13 will not be signing?
- 14 MR. SWEARENGEN: Calpine, we have not heard
- 15 from Calpine. I believe AARP has indicated that they will
- 16 not sign. The Office of the Public Counsel has indicated
- 17 that it will not sign, and I believe the same is for the
- 18 Empire District Electric Company.
- 19 JUDGE WOODRUFF: Okay. Let's go through
- 20 them one by one. Calpine I understand, as I recall, has
- 21 filed for bankruptcy; is that correct?
- 22 MR. SWEARENGEN: I believe that's true.
- 23 JUDGE WOODRUFF: It's my understanding that
- 24 they have not really participated in the latter stages of
- 25 this case at all. Is that true?

- 1 MR. SWEARENGEN: That's correct.
- JUDGE WOODRUFF: Okay. Let's deal with The
- 3 Empire District then. Also, I know at the beginning of
- 4 the proceeding Mr. Keevil indicated he would not be
- 5 participating to any great extent in this case. Have they
- 6 been kept informed of --
- 7 MR. SWEARENGEN: They have been kept
- 8 informed, your Honor, and it's my understanding -- and I'd
- 9 prefer that Mr. Keevil speak for himself, but he's
- 10 indicated to me that while they're not going to sign this,
- 11 they have no intention of opposing it and requesting a
- 12 hearing.
- JUDGE WOODRUFF: All right. Thank you.
- 14 Then I'll turn to Public Counsel. What is your position
- 15 going to be, Mr. Mills?
- 16 MR. MILLS: Well, of course, I haven't seen
- 17 the document as it's filed, but assuming that it's filed
- 18 in conformance with the drafts that I have seen, it is my
- 19 intention to not be a signatory, but also to not request a
- 20 hearing.
- JUDGE WOODRUFF: Thank you. Mr. Coffman?
- 22 MR. COFFMAN: Thank you. I think likely --
- 23 I will likely be in the same situation as the Public
- 24 Counsel, although my client has asked that it wait until
- 25 this document is actually filed. There were many language

- 1 changes that have been floating around the last few
- 2 months, and some of the concerns of my client relate to
- 3 some of these language changes. So I can't today commit
- 4 whether or not AARP would request a hearing or object to
- 5 any specific issues until we've seen the final document
- 6 and have a chance to look at it.
- 7 JUDGE WOODRUFF: Certainly I understand the
- 8 need to actually see the document. Of course, the
- 9 Commission's not seen the document at this point yet
- 10 either.
- 11 MR. COFFMAN: But we are very well aware of
- 12 the time limit that begins when the document is filed and
- 13 would make a decision within that time what to do.
- 14 JUDGE WOODRUFF: And that's the seven days
- 15 allowed by the regulation?
- MR. COFFMAN: That's right.
- 17 JUDGE WOODRUFF: All right. And this
- 18 Stipulation & Agreement that has been reached, is that in
- 19 both the electric as well as the steam case?
- 20 MR. SWEARENGEN: There's a separate
- 21 document that's being prepared in connection with the
- 22 steam case, your Honor. I do not believe it is quite as
- 23 far along as we are in the electric case. I think the
- 24 issue there is examining the tariffs that would implement
- 25 the agreement. Maybe Mr. Williams can shed some light on

- 1 that. But I'm hopeful that we'll have that accomplished
- 2 in the next day or so.
- JUDGE WOODRUFF: Mr. Williams?
- 4 MR. WILLIAMS: I'm unable to shed any light
- 5 on the steam case. To my knowledge, Staff's been apprised
- 6 among some of the parties that have been negotiating
- 7 towards a Stipulation & Agreement as to the path they're
- 8 taking, but beyond that, I'm unaware of any involvement
- 9 Staff has had with regard to the steam case.
- 10 JUDGE WOODRUFF: Let me ask Mr. Swearengen,
- 11 do you anticipate any problems with finalizing that
- 12 settlement?
- MR. SWEARENGEN: I really don't, your
- 14 Honor. Once again, I think the issue there is the Staff
- 15 is reviewing the tariffs that would implement it and make
- 16 sure there are no problems with those tariffs. We've done
- 17 the same thing on the electric side. We actually have an
- 18 agreement among those signing parties as to the tariffs
- 19 that will implement the agreement. So that eliminates a
- 20 lot of problems down the road should the Commission
- 21 approve it.
- JUDGE WOODRUFF: All right. And how
- 23 quickly do you anticipate actually filing the document?
- 24 Are we waiting for signatures yet?
- MR. SWEARENGEN: I would like to file the

- 1 document in the electric case this afternoon. I think
- 2 we're waiting just to hear from Major Paulson and the
- 3 Department of Natural Resources. Everyone else has either
- 4 signed or authorized someone to sign on their behalf. So
- 5 we'll file something today.
- JUDGE WOODRUFF: I know the Commissioners
- 7 are anxious to see it.
- 8 MR. SWEARENGEN: Yes. We'll file something
- 9 today in the electric case.
- 10 JUDGE WOODRUFF: Very good. Anything else
- 11 anyone wants to bring up?
- 12 All right. Well, the Commissioners I
- 13 expect will -- as I indicated, are anxious to see the
- 14 document. They'll likely request an on-the-record
- 15 presentation to ask questions about the document once
- 16 they've seen it. I have not been instructed as to when
- 17 that will happen. Presumably next week sometime. But I
- 18 will issue a subsequent order telling you when that will
- 19 be. Is there any days that anyone particularly doesn't
- 20 want to be here?
- 21 MR. WILLIAMS: Judge, as to that, the
- 22 Stipulation & Agreement contemplates the Staff filing a
- 23 memorandum and the other parties having five days to
- 24 respond to that.
- 25 MR. COFFMAN: If I can ask Staff, is there

- 1 a target date for that suggestion document being filed?
- 2 MR. WILLIAMS: Well, given that my time has
- 3 been spent on the negotiations over the settlement
- 4 agreement, it's -- I'm going to need a few days in order
- 5 to get the suggestions in order for filing. I don't have
- 6 a specific date in mind, but I know it will take a few
- 7 days. It's not something I plan on holding up.
- JUDGE WOODRUFF: Well, obviously the
- 9 Commission wants to be able to put this to bed as soon as
- 10 possible, and particularly if there was some problem with
- 11 it that the Commission finds with the Stipulation &
- 12 Agreement and were to decide that they were not going to
- 13 accept it, it would leave us a very short amount of time
- 14 to conduct a hearing. I'll cross my fingers and knock on
- 15 wood about that.
- 16 All right. Well, at this point, then, I
- 17 will continue this hearing indefinitely. There will be a
- 18 further order indicating whether or not there will be a
- 19 need for an on-the-record presentation, and I look forward
- 20 to seeing the document filed. Thank you.
- We're off the record.
- 22 WHEREUPON, the hearing of this case was
- 23 concluded.
