On October 14, 2022, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed a steam tariff sheet (Tracking No. YH-2023-0068) to change the calculation of Evergy West's Quarterly Cost Adjustment (QCA) rider for steam service.
