**ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF**

Issue Date: May 23, 2022

Effective Date: June 1, 2022

The Missouri Public Service Commission is approving the pending tariff sheet, which sets forth the quarterly cost adjustment (“QCA”) for Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) in calendar year 2022, first quarter. EMW filed the tariff on April 15, 2022, with an effective date of June 1, 2022. Staff filed its recommendation on May 5, 2022, stating that the tariff meets the requirements of EMW’s tariff sheets 6.6 through 6.10. Staff recommends the Commission approve that tariff. The Commission received no other response to the tariff.

The Commission concludes that the tariff complies with EMW’s tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates. The Commission will approve the tariff.
