**STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEETS**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, for its recommendation to approve tariff sheets, respectfully states:

1. In the attached Memorandum (Appendix A) the Staff recommends the Missouri Public Service Commission (Commission) approve the tariff sheets KCP&L Greater Missouri Operations Company (GMO) filed on November 12, 2009, to become effective December 1, 2009.

2. On October 15, 2009 GMO filed tariff sheets<sup>1</sup> to make a quarterly cost adjustment required as part of the Stipulation and Agreement approved by the Commission in Case No. HR-2009-0092. That Stipulation and Agreement includes a “fuel rider” that requires quarterly rate adjustments, with not more frequent than annual true-ups.

3. Staff reviewed the October 15 tariff sheets, and identified an error or miscalculation. Staff contacted GMO to discuss that error or miscalculation.

4. On November 12, 2009 GMO withdrew its tariff sheets filed October 15, and filed corrected tariff sheets.<sup>2</sup>

5. Staff reviewed the November 12 tariff sheets, and is of the opinion that the quarterly cost adjustment for the 2009 Q3 has been calculated in accordance with the provisions

of the Quarterly Cost Adjustment Rider tariff sheets and complies with the Commission's Order in HR-2009-0092.

6. The Staff recommends the Commission issue an order approving the proposed tariff sheets to be effective December 1, 2009 as requested by the company, for good cause shown.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission approve to become effective December 1, 2009, for good cause shown, the Tariff Sheets GMO filed on November 12, 2009, to wit:
