**ORDER TO FILE CONFORMING TARIFF**

On October 26, 2018, a Non-Unanimous Stipulation and Agreement (“Agreement”) was filed by the Staff of the Missouri Public Service Commission and Veolia Energy Kansas City, Inc. Included as Appendix D to the Agreement were sample tariff sheets conforming to the agreement.

The proposed tariff sheets included as Appendix D to the Agreement are not tariff sheets filed by the company with the Commission, but merely an exhibit to the Agreement. The company shall file conforming tariffs with the Commission along with any request for expedited treatment.

**THE COMMISSION ORDERS THAT:**

1. Veolia Energy Kansas City, Inc. shall file tariffs in compliance with the terms of the Agreement and the sample tariff sheets included as Appendix D to the Agreement no later than November 2, 2018.
2. The Commission’s Staff shall review any compliance tariffs and file a report regarding the compliance of Veolia’s tariff sheets no later than November 6, 2018.
3. Any other recommendations regarding the compliance of Veolia’s tariff sheets are to be filed no later than November 6, 2018.

4. This order is effective when issued.


