ORDER ENLARGING TIME FOR STAFF TO FILE A RECOMMENDATION

On February 1, 2022, Vicinity Energy, Kansas City, Inc. (Vicinity) filed tariff sheets (Tracking No. YH-2022-0218) to change Vicinity's production adjustment cost clause (PACC) rates for steam service. On February 2, 2022, The Commission directed Staff to file a recommendation regarding the proposed tariff sheets by March 4, 2022. On March 4, 2022, Staff filed a Motion for enlargement of the time to file its Staff recommendation, citing difficulties with Staff availability and the desire to facilitate discussion with Vicinity about its filing. The Commission finds Staff's request to be reasonable and will enlarge the time for Staff to file its recommendation for one week, as well as enlarging the time for any party to comment on the tariff sheets or the Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Vicinity's revised tariff sheets no later than March 11, 2022.
2. Any party wishing to comment on the tariff sheets or Staff's recommendation shall do so no later than March 18, 2022.
3. This order shall be effective when issued.
