On October 29, 2018, Spire Missouri Inc. (Spire Missouri), on behalf of its operating units, Spire Missouri East and Spire Missouri West filed a request for waiver of the 60-day notice provisions of Commission Rule 4 CSR 240-4.017(1). Spire Missouri indicates its intent to file its next infrastructure system replacement surcharge (ISRS) filing in December 2018.

Spire Missouri states in its request that good cause to waive the rule exists because it has had no communication with the Commission within the prior 150 days regarding any substantive issues likely to be in this case outside of pleadings or other public communications. Spire Missouri also indicates that it generally files ISRS cases twice per year and, as a result, these filings are expected by the parties usually involved.

The Commission will set a time for replies to the request for waiver.

THE COMMISSION ORDERS THAT:

1. Any responses to Spire Missouri Inc.'s request for a waiver of Commission

Rule 4 CSR 240-4.017(1) shall be filed no later than November 9, 2018.
