On June 3, 2022, Spire Missouri Inc., (Spire) filed a petition requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges. Staff filed a recommendation about Spire's petition on September 1, 2022. Spire filed a response on September 8, 2022, stating that it does not fully agree with Staff's recommendation but that it would be filing a joint stipulation to resolve this case, or a status report by September 15, 2022. No joint stipulation or status report were received on September 15, 2022. Because the Commission's deadline to act on this matter is November 29, 2022, the Commission will order Spire to file status report.

THE COMMISSION ORDERS THAT:

1. Spire shall file a status report informing the Commission of the status of this case no later than September 23, 2022.

2. This order is effective when issued.
