## ORDER APPROVING TARIFF SHEETS AND SETTING INTERIM RATES

Issue Date: November 15, 2012 Effective Date: November 17, 2012

The Missouri Public Service Commission is approving proposed tariff sheets ("tariffs"), which will decrease the Purchased Gas Adjustment (PGA) factor of Summit Natural Gas of Missouri, Inc. ("SNG"), resulting in the following changes in dollars per hundred cubic feet:

Service Area	Current PGA	Proposed PGA	Difference	Average Customer's Winter Monthly Decrease
Northern	0.4989	0.3955	0.1034	\$11.23
Southern	0.5364	0.4170	0.1194	\$ 9.61
Lake of the Ozarks	0.5364	0.4170	0.1194	\$ 9.61

On November 2, 2012, SNG filed the tariffs. The tariffs bear proposed effective dates of November 17, 2012. The tariffs reflect a change in SNG's PGA factor as a result of estimated changes in the cost of natural gas for the 2012-2013 winter season. The Commission's Staff filed its recommendation on November 9, 2012. Staff recommends the rates be approved on an interim basis, subject to refund pending final Commission decision in this case. No hearing is required to order those unopposed

provisions, so this action is not a contested case,<sup>3</sup> and the Commission need not separately state its findings of fact.

The Commission finds that the tariffs conform to SNG's Commission-approved PGA Clause, so the Commission will approve the tariffs. The absence of opposition also constitutes good cause for the Commission to make this order effective in less than 30 days. Therefore, the Commission will approve the tariffs on an interim basis, subject to refund, pending final Commission decision in this case.

In addition, Staff asks to file its results and recommendations regarding the information included in this ACA filing to the Commission on or before December 20, 2013, and the Commission will grant that request.

## THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets assigned Tracking Number YG-2013-0223, are approved on an interim basis, subject to refund, pending final Commission decision in this case. The tariff sheets approved are:
